## **NEW FIREARMS PURCHASE PERMIT PROCEDURES**

In order to make it convenient to obtain a Firearms Purchase Permit for Cass County citizens, you may print off the application and submit it via U.S. mail. Instructions for submitting an application are as follows:

- 1. You must be 21 years of age or older to submit an application.
- 2. Carefully read and complete the application. If there are any questions that do not apply to you, please place a N/A in the box. Have it notarized on the second page of the application.
- 3. Include a phone number at the top of the application.
- 4. Mail the completed application with a photocopy of your Nebraska Driver's license with your current address (if you have a PO Box, you will need to add that as well) and, if applicable, a photocopy of your permanent resident card and the \$5.00 fee, payable in cash or check, to:
